The kittens were cute but she was concerned about more litters in the future and was thankful when she found FCCO. Lisa and the cats made the hour-long trip to FCCO's clinic where the cats were spayed and vaccinated.

Dear Friends,

It is with deep gratitude and appreciation that I share with you the Feral Cat Coalition of Oregon's Annual Report for the fiscal year ending September 30, 2023, highlighting many achievements from this fiscal year.

Your support played a pivotal role in enabling us to accomplish something truly remarkable – together, we improved the lives of 8,286 feral and stray cats who came to us from 24 counties across Oregon and Washington. This total is nearly double the surgeries we were providing prior to the pandemic, underscoring the sustained need for our feral and stray cat spay/neuter services.

For 71% of the caregivers seeking our services, they reported their household income as being less than \$50,000 per year. They not only need affordable spay/neuter services, but they need food support and assistance finding homes for kittens. Through our Kibble Closet food pantry we disbursed 8,503 pounds of food to cats coming in for surgery – a 27% increase over last year. And our Kitten Caboose program, which gets tame kittens off the streets and into partner shelters where they can find homes, helped 368 kittens live better lives.

As we reflect on these achievements, please know that you play an integral part. Your compassion and generosity translate into tangible, positive change for the cats, and we are immensely grateful. We look forward to keeping you updated on the continued impact of your support.



39% of the cats traveled from outside of the Portland metro area to receive our spay/neuter services.
